#### Piedmont Chapter programs for July and August 2010

Vice President Allen Greenly introduced the guest speaker, Alan I. Davies, who gave a presentation on his book, A Life in Shadow: Divine Spark or Chemical Imbalance? Mr. Davies, was born in Great Britain in 1932 and, as a child experienced evacuations from London, both during the Summer of 1940 when Germany sent numerous air strikes against Britain in what is known as the Battle of Britain and again in the Summer of 1944 when Germany launched numerous drone attacks against Britain, accounting for approximately 6,500 deaths and 18,000 injuries. Mr. Davies recounted numerous anecdotes as to how the children who were evacuated as well as the hosts in the countryside had to make numerous adjustments to their normal daily routine. He also noted that Elizabeth Taylor, who was also born in 1932, was perhaps the most famous child evacuee.

Mr. Davies gave a brief summary of his life following the war, including his eventual relocation to Canada and the United States. Mr. Davies used some interesting graphics to illustrate the main details of his talk.

Speaker at the August Meeting. State Representative Tom Knox represents the 24th District of the Georgia House of Representatives. Representative Knox began his political career at age nine campaigning for Dwight Eisenhower for President. He was first elected to the Georgia House of Representatives in 2000. Born in St. Louis, Missouri, he was educated at St. Louis Preparatory Seminary and attended St. Louis University and Cardinal Glenna College majoring in philosophy and education. He also attended St. Louis University and Woodrow Wilson College School of Law. He earned his JD in 1974 and was admitted to the practice of law in 1975. Representative Knox is married to Michele Knox,. He and Michele live on Lake Lanier and enjoy boating and water sports.

Representative Knox currently serves as Chairman of the House Insurance Committee. He spoke about healthcare and some of the issues which the state of Georgia will face as the new federal program is implemented.

# Patriot Militia General Andrew Pickens



Andrew Pickens was born near Paxtang, Pennsylvania in Bucks County on September 19, 1739. His parents were French Huguenots, who had fled to Scotland, then Ireland before migrating to America from Ulster. His family traveled the Great Wagon Road and settled in the Waxhaws region of the Carolinas.

Pickens served in the Cherokee War of 1760-61. In 1761, he served as an officer in a provincial regiment that accompanied British Colonel James Grant against Lower Cherokee settlements. In 1764, Pickens and his brother sold their farm in the Waxhaws and bought land in the Long Cane Creek settlements in Abbeville County in southwestern South Carolina near the Georgia border. There, he met Rebecca Calhoun. In 1765, they married and would have 12 children. In 1768, Pickens built a blockhouse as a defense against Indian attacks and a base for Indian trading. He was a successful farmer and was serving as a justice of the peace as the war began.

In 1775, Pickens became a captain of Patriot militia. On November 19, 1775, he was at Ninety-Six, South Carolina with Major Andrew Williamson and 600 militia. A Tory force of 1,800 drove them into the fort there. After two days, a truce was negotiated. He then participated in Snow's Campaign in the winter of 1775. In Fall of 1776, as a major of the militia, Pickens joined Williamson's expedition against the Cherokee Indians who had allied themselves with the Loyalists. In 1778, Pickens joined Williamson's failed attempt to recapture Augusta, Georgia. On February 14, 1779, Pickens defeated Colonel Boyd at Kettle Creek, Georgia. He briefly surrendered and went on parole following the Surrender of Charleston in May 1780.

After returning to action, he participated in the Battle of Cowpens, Siege of Augusta, Siege of Ninety-Six and Battle of Eutaw Springs. Andrew Pickens participated in the Battle of Eutaw Springs, South Carolina on September 8, 1781. Major General Nathanael Greene put the militia on the front line, and Pickens commanded the left wing. Pickens was wounded at the battle. In November 1781, he led a three week campaign against the Cherokee Indians. In September 1782, he and Elijah Clarke succeeded in forcing the Indians to surrender claim to all lands south of the Savannah River and east of the Chattahoochee River.


In 1782, Pickens was elected to represent the Ninety-Six District in the assembly, serving there until 1793, when he went to Congress for one term. Pickens acquired frontier lands along the Keowee River and built his home named Hopewell in Oconee, Georgia. After living there a number of years, he moved to the Pendleton District of South Carolina. He served as a political middleman between the Indians and the new American nation. He died suddenly on August 11, 1817. His son, Andrew Pickens (1779-1838) served as Governor of South Carolina from 1816-1818. In 1826, Pickens County was created and named in his honor.

In Memoriam



Compatriot Jon Paul "J.P." Livaditis, beloved son of Carol and Elias Livaditis, shown in the photo above went to meet the Lord on July 29, 2010.

J.P. was a graduate of the University of Georgia. He was a life long member of Peachtree Christian Church. He was also a member of the Piedmont Chapter of the Sons of the American Revolution; the Huguenot Society of the Founders of Manakin; and the Dawson County Democrats. Following his graduation, he worked as a page in the Georgia State Senate Office where, during the legislative session, he operated the microphones recognizing senators as they took their turn to speak.

More recently, he worked as an on line instructor assisting young people across the nation with math, English, and history. As an avid astronomer he enjoyed gazing at beautiful star-lit skies and sharing with companions, pointing out stars and constellations.

Seldom do we, as citizens, have great opportunities to advance that vision, but lesser ones present themselves daily. Piedmont Compatriot Robert J. "Bob" Buck died in his sleep on July 17, 2010. He was age 87.



Bob and I were classmates in the Garden City, Long Island, Public Schools from Second Grade until our graduation from Garden City High School in 1940. Bob was born 4 April 1923 in Providence, RI, but moved to Long Island as a young boy. We were not close buddies since we lived in different sections of the village, attended different churches, etc., but we were close classmates at school. Together we learned grammar, geography, algebra, and U.S. history. And together we scuffled over baseballs, basketballs and soccer balls. After graduation, Bob enrolled at Williams College in Massachusetts while I attended Lafayette College in Pennsylvania. Soon both of us were called into the military services during WW II -- Bob in the Navy, and I in the Army. For many years we saw little of each other as we followed our individual careers.

Bob chose a career in advertising/marketing with various agencies in New York City while still living in Garden City with his bride, the former Ruth Burns, also a Garden City High School graduate, and their three children: Catherine (Leary), Andrew J., and Paul Buck. At one time he was Vice President of Dancer-Fitzgerald Sample in New York. In 1975 he came to Marietta to work with Coca

Cola where he served as Director of Marketing before retiring.

When I learned he had moved to Alanta, where I had come in 1965 to serve as Director of Health and Human Services at the Southern Regional Education Board, we got together for lunches a few times. After learning of my interest in McPheeters family research, he told me that he had just joined the new Piedmont Chapter of SAR after transferring from the Atlanta Chapter. Bob urged me to join the Piedmont Chapter on the line of my third great-grandfather, John McPheeters, a 17 year old Private in the Augusta County, Virginia, Militia, and he sponsored my application.

Bob served for six years as Piedmont Chapter's Chaplain and wrote a monthly column for the Piper, while I was the Chapter's Historian. He also chaired the Chapter's Schools Committee and was very active in promoting the School Poster Contest for elementary schools and the Knight Essay Contest for high school students.

In later years Bob developed mobility problems and two hip fractures. For about a year I drove him to and back home from our Piedmont Chapter's monthly meetings until getting in and out of a car became too difficult.

Bob Buck was a soft-spoken person, but wiity and bright. He was a good man, a good friend, and a great Compatriot! Funeral services were held at Saint Peter and Saint Paul Episcopal Church in Marietta on 23 July with an Honor Guard from the GASSAR Color Guard and full military honors.

#### Remembering our Fallen By George Thurmond

**Robert J. "Bob" Buck.** Bob was a fixture at the Piedmont Chapter when I joined the SAR. His warm, engaging smile and humor were notable. His service for six years as our Chaplain was remarkable. Bob would "carve every word" in his invocations and benedictions, writing them out in longhand, for each was treated as a special occasion. Bob had a keen interest in our youth and youth programs. He was the original chairman of the poster contest, starting, I believe, at Mt. Bethel Elementary near his home in Indian Hills. We have had considerable success with that school ever since, winning the state poster contest several times. As Schools Chairman, Bob had an unusual interest in the development of "his" winning students. He maintained correspondence with them after they left for college and would, on occasion, update us with their progress in college. At one of my first meetings, Bob was part of the program, speaking about his Revolutionary War ancestor, Colonel Jonathan Buck, for whom Bucksport, Maine is named. He arranged for a grave marking of his ancestor, returning from Maine with a Tee shirt that he sported at our next meeting.

Bob had a special relationship with Harold McPheeters whom he recruited into the chapter. They were high school classmates on Long Island, New York. Following the memorial service for Bob, President Bhame presented his widow, Ruth, with member medallion with the inscription: "Presented in grateful appreciation of the membership of Robert. J. "Bob" Buck in the Piedmont Chapter, SAR." Bob's remains were interred in Arlington Cemetery, Arlington, Virginia. Bob, you served us well. Rest in peace.

Jon Paul Livaditis. "J. P." was the grandson of past president Scott Ray. He joined our chapter in 2000 when Scott reinstated his membership, formerly with the Atlanta Chapter. Because J.P. lived in Dawsonville, he was not able to attend many meetings but always enjoyed those that he could attend. He would always engage the speaker in dialog after the meetings and enjoyed fellowship with our members. I remember on one occasion when he and Scott attended the annual Kings Mountain Historical Sites program in Kings Mountain, South Carolina. That was an especially rewarding experience for all. J.P.'s Revolutionary War ancestor was Jacob Braselton who fought in Maryland. This is the same ancestor shared with Kit Braselton, past Georgia Society President. Following the memorial service at Peachtree Christian Church, his parents Elias and Carol Livaditis were presented with a member medallion by President Carl Bhame with the inscription: "Presented in grateful appreciation of the membership of Jon Paul "J.P." Livaditis in the Piedmont Chapter, SAR."

J. P., you will be missed. Rest in peace.

President Carl Bhame informed the members present of awards acquired by the Chapter and its members at the recent NASSAR Conference in Cleveland, Ohio, specifically the following awards were made:

Patriots Day CAAH flag streamer for the Chapter's support (\$500) during 2009-2010

Certificate, medal and letter to Jack Ferguson recognizing him as a George Washington Fellow due to his support of the George Washington Endowment Fund

Certificate to Piedmont Piper editor Gerald Breed recognizing his efforts in achieving a first place award to the Chapter for a multiple page newsletter. The Chapter also received a \$100 check from the Maryland SAR Society, which funds this category of awards.

Honorable Mention Award in the Liberty Bell Americanism contest for the number of new members recruited in 2009 and exemplary Chapter performance. The Chapter had placed first in this category previously and could not repeat two years in a row. Bob Sapp was recognized at the Congress with two more oak leaf clusters for his well decorated Liberty Bell Medal, which recognizes his continued good work in obtaining new NASSAR memberships. Bob now has nine oak leaf clusters, each of which recognizes his obtaining ten additional new members for which he has been the first signer, with over 100 new members to his credit. Both Bob Sapp and George Thurmond received Meritorious Service Awards from NASSAR again a "repeat" for both gentlemen. On Saturday July 31, 2010, the Piedmont Chapter Color Guard gave an enlightening and entertaining presentation of the "Travelling Trunk" items to parents and children at the Roswell Library. The thrust of this instructive session gave the audience a glimpse into the lifestyle of our patriot ancestors when the Revolutionary War was in progress. This educational idea is the creative result of Terry Manning's historical perspective on artifacts and reproductions from Colonial life in our country, while he was GASSAR Education Chairman. Paul Prescott, Bob Sapp, George Thurmond and Jack Ferguson each presented interesting items from the trunk, some being rather rare and odd. The "Housewife", for example, shown by Bob Sapp is a repair kit for fixing fabric and clothing with clever ways to package the thread, needle, etc. Other items for candle making, eating, cooking, writing and hunting were part of the morning's session. Demonstration of the authentic musket materials and handling brought many questions from the young people, helping them to realize the difficulties and trials of our ancestors to eke out a living in their daily labors and then to run the additional risks and work while fighting during the war for individual rights, safety and principles. There are two similar Travelling Trunks now available from the GASSAR resources.

To close the session the children, parents and guests joined the Color Guard members in the Pledge of Allegiance to our nation's flag. Shown below are some photos of the items discussed and those in attendance.
